Dear Ms. Jenkins:

The Commission's December 21, 2010 Finding and Order in Case No. 10-200-GA-ATA authorized the discontinuation of The East Ohio Gas Company d/b/a Dominion East Ohio ("DEO") Low-use, Low-income Pilot Program. Pursuant to this Order, DEO is withdrawing its General Sales Service – Low Usage Heat Pilot Program ("GSS-LU") (Second Revised Sheet No. F-GSS-LU 1 – 2) and Energy Choice Transportation Service – Low Usage Pilot Program ("ECTS-LUU") (Third Revised Sheet No. F-ECTS-LU 1 – 3), effective April 1, 2011. The withdrawal of both tariffs is evidenced in the four copies of the Table of Contents attached hereto.

Customers formerly receiving GSS-LU service will be transitioned to General Sales Service – Residential rates, and customers receiving ECTS-LUU service will be transitioned to Energy Choice Transportation Service – Residential rates.

Please file a copy of the final tariff in the above-referenced dockets, and distribute copies to the Rates and Tariffs, Energy and Water Division of the Commission's Utilities Department.
