On March 30, 2011, the Commission issued a Finding and Order in Case No. 11-281-EL-FAC approved a new Fuel Adjustment Clause rate for Columbus Southern Power Company (CSP) and authorized CSP to file final compliance tariffs (Ohio Power Company's FAC rate is not changing).

One copy of CSP's tariff filing should be filed in Case No. 89-6003-EL-TRF. One copy of CSP's tariff filing should be placed in Case No. 11-281-EL-FAC. Two copies of CSP's tariff filing have been designated for distribution to the Rates and Tariffs, Energy and Water Division of the Commission's Utilities Department.
