- (3) **NET ADJUSTED RATE:** The algebraic sum of Base Rate plus PGA.
- (4) **BASE COST OF GAS:** The prevailing Cost of Purchased Gas at the time of OVGC's last General Rate Case.
- (5) **GAS COST RECOVERY (GCR):** The algebraic sum of Base Cost of Gas plus PGA.
