#### 19.1 <u>Termination of Service by the Subscriber's Request</u>

- 19.1.1 <u>General</u>
  - A. If service is discontinued within a period less than one month following the date of installation or conversion, the minimum charge for one month's use of service at the rate in effect during the period of service plus any charges for toll service, service connection, nonrecurring and construction charges will apply.

- 19.2 <u>Termination of Service by the Company</u>
  - 19.2.1 General
    - A. The Telephone Company must notify, or attempt to notify, a subscriber before service is refused or disconnected when any of the following conditions exist:
      - 1. A violation of or noncompliance with the Commission's current regulations governing service supplied by the Telephone Company;
      - 2. A violation of or noncompliance with the Telephone Company rules or tariffs;
      - 3. A failure to comply with municipal ordinances or other laws pertaining to telecommunications services; or
      - 4. A refusal by the subscriber to permit the Telephone Company necessary accesses to its facilities or equipment.
    - B. The Telephone Company may not disconnect the local exchange or interexchange service or a subscriber who pays the Company the total amount due (or an amount agreed upon between the Company and the subscriber to prevent disconnection) on the customer's account by the close of business on the disconnection date listed on the disconnection notice.
    - C. The Telephone Company may disconnect the subscriber's service without notice for emergency reasons, upon a court order, or if service was obtained in violation of the tariff.
    - D. Residential customers whose telephone services have been temporarily denied for nonpayment will continue to have access to 9-1-1 Service (outgoing service only) for fourteen (14) days.
    - E. Disconnection of a customer's service will be made in accordance with the rules specified in this tariff as well as the Minimum Telephone Service Standards.
    - F. Inclusion of early termination liability by the Company in its tariff or a contract does not constitute a determination by the Commission that the termination liability imposed by the Company is approved or sanctioned by the Commission. Customers shall be free to pursue whatever legal remedies thy may have should a dispute arise.
