NOTICE OF CLARIFICATION AND WITHDRAWAL OF APPLICATION FOR REHEARING OF THE OHIO ENERGY GROUP

On April 21, 2011, The Ohio Energy Group ("OEG") filed an Application for Rehearing in this case. The rehearing asserted that the Commission's March 23, 2011 Order should be modified to allocate energy efficiency and peak demand reduction ("EE/PDR") costs to Rates GP, GSU and GT on an individual rate schedule basis, rather than on a combined basis. On May 2, 2011, Ohio Edison Company, The Cleveland Electric Illuminating Company and The Toledo Edison Company (collectively, "Companies") filed a response. The response explained and clarified that while the initial allocation of EE/PDR program costs would be done on a combined basis, the reconciliation or true up of the program costs recovered through the Rider DSE2 charge would be done based upon the specific EE/PDR program costs incurred individually by customers on Rates GP, GSU and GT. In other words,

after the reconciliation or true up occurs, the customers on Rates GP, GSU and GT will only be charged for EE/PDR direct program costs incurred with respect to their individual rate schedule. During the reconciliation or true-up, common costs (those costs that cannot be assigned to a specific customer or rate schedule) will continue to be allocated by kWh usage to all rate schedules benefiting from EE/PDR programs.

Based upon the clarification in the response of the Companies, OEG withdrawals its Application for Rehearing. Counsel for the Companies has authorized the undersigned counsel to represent that the Companies agree with this interpretation of how they intend to allocate and reconcile EE/PDR costs to Rates GP, GSU and GT.
