

As indicated in Section II of the Offering Form, the Company intends to continue to offer access services and transit services in the State of Ohio. With regard to the former, the Company will continue to maintain its P.U.C.O. Tariff No. 4 with the Commission. Accordingly, please note that this filing pertains only to the detariffing of the Company's Tariff Nos. 1 and 2 (pursuant to which, the Company is not currently offering services to any Ohio customers). The Company will continue maintain the authority granted to it by the Commission under Certificate of Public Convenience and Necessity No. 90-9283 and continue to provide such access and transit services.

With regard to the Application, please note that the Company has intentionally omitted all exhibits otherwise required by Part II of the Application, pursuant to conversations with Commission staff. No tariff pages are being revised by this filing. Further, as noted above, the company is not currently providing the relevant tariffed services to any Ohio customers, and accordingly, there are no parties who require notice of this filing.






