

**JOINT APPLICATION TO TRANSFER A CERTIFICATE  
TO AMERICAN MUNICIPAL POWER, INC.**

Pursuant to R.C. §4906.04, FirstEnergy Generation Corp. ("FirstEnergy"), holder of a Certificate of Environmental Compatibility and Public Need ("Certificate") granted by the Ohio Power Siting Board ("OPSB") to Fremont Energy Center LLC ("Fremont") on May 1, 2001, and transferred to FirstEnergy on March 3, 2008, for the construction of a 704 MW natural gas-fired combined-cycle electric generating facility ("Freemont Energy Center"), and American Municipal Power, Inc. ("AMP"), the proposed transferee (together "Joint Applicants"), jointly move the OPSB for an Order transferring the Certificate for the Fremont Energy Center to AMP. In its Opinion, Order and Certificate, the OPSB approved the construction of the Freemont Energy Center in Sandusky County, near Fremont, Ohio. The construction of the generating facility is now approximately ninety nine percent (99%) complete.


FirstEnergy and AMP have entered into an agreement whereby all the assets of this project, including the Certificate, permits and other authorizations necessary for the construction of the Fremont Energy Center, will be transferred to AMP. AMP will promptly complete any remaining construction of the Fremont Energy Center and will do so in full compliance with the terms and conditions of the Certificate issued by the Board

on May 1, 2001, as subsequently amended, and as transferred on March 3, 2008. The attached letter from Jolene Thompson, Senior Vice President of Member Services and External Affairs of AMP, confirms that AMP accepts and will comply with the terms and conditions in the Certificate, as amended.

Ohio Revised Code Section ("R.C.") 4906.04 permits the OPSB to approve a change in ownership of a Certificate where a new third-party entity proposes to acquire the Certificate and the third-party agrees to comply with the terms, conditions and any modifications of a Certificate. AMP has agreed to comply with the Certificate, as amended, and as such meets the requirements for the transfer of the Certificate for the Freemont Energy Center.

WHEREFORE, Joint Applicants respectfully request that pursuant to R.C. §4906.04, the Board find that AMP has agreed to accept the terms and conditions of the Certificate for the Freemont Energy Center and that based on such finding it issue an Order transferring the Certificate to AMP.
