**JOINT APPLICATION TO TRANSFER A CERTIFICATE OF ENVIRONMENTAL
COMPATIBILITY AND PUBLIC NEED TO
AEP OHIO TRANSMISSION COMPANY, INC.**

The Joint Applicants in this Application include Columbus Southern Power Company ("CSP"), holder of a Certificate of Environmental Compatibility and Public Need granted by the Ohio Power Siting Board ("Board") on September 21, 2009 and as amended by the September 7, 2010 entry, and AEP Ohio Transmission Company, Inc. ("Ohio Transco"), the proposed transferee (together, "Joint Applicants").

In its September 21, 2009 Opinion, Order and Certificate, the Board approved an application of CSP for a certificate to construct a 6.3 mile single-circuit 138-kilovolt (kV) transmission line in Franklin County, Ohio ("Roberts-OSU Project"). The Roberts-OSU Project is now 25 % complete.

Ohio Revised Code ("R.C.") 4906.04 applies to a change in ownership of the Certificate where a new third-party entity proposes to acquire the certificate and provides that


the Board determine whether a certificate should be transferred to the new third-party entity and, if so, to approve the transfer.

Joint Applicants have entered into an agreement whereby all of the assets of this project, including the Certificate, permits and other authorizations pertaining to the Roberts-OSU Project, will be transferred to Ohio Transco. Ohio Transco plans to continue construction of the facility in accordance with the Certificate issued by the Board on September 21, 2009 and as amended by the September 7, 2010 Order On Certificate Amendment. Ohio Transco pledges to comply with the terms, conditions and modifications contained in the Certificate pursuant to R.C. 4906.04, as evidenced by the attached correspondence from Ms. Lisa Barton, Vice President AEP Ohio Transmission Company, Inc. There should be no change other than the holder of the certificate and therefore no impact on any of the political subdivisions along the route

To ensure notice of the requested transfer, the Joint applicants have provided notice of this filing to the chief executive officer of each municipal corporation, county, township, and the head of each public agency charged with the duty of protection the environment or of planning land use in the area in which any portion of the facility is to be located. A service copy of this request is also being sent to the City of Upper Arlington who participated in the hearing and agreement approved by the Board


WHEREFORE, Joint Applicants respectfully request that, pursuant to R.C. 4906.04,
