### FINDING AND ORDER

#### The Commission finds:

- (1) The Applicants, Ohio Edison Company, The Cleveland Electric Illuminating Company, and The Toledo Edison Company, are public utilities as defined in Section 4905.02, Revised Code, and, as such, are subject to the jurisdiction of this Commission.
- (2) On May 10, 2011, the Applicants filed updated tariffs in response to and in accordance with the Commission Opinion and Order in this proceeding dated August 25, 2010, adopting the Stipulation and Recommendation, Supplemental Stipulation, and Second Supplemental Stipulation (Order).
- (3) The Applicants' May 10, 2011 filing includes new and modified riders. Specifically, existing Riders ELR, OLR, GCR, RTP, CPP, GEN and EDR have been modified in accordance with the Order. New Riders NMB (Non-Market Based Services) and DCR (Delivery Capital Recovery) were also included in the filing. Riders AMI and DSE originating from Case Nos. 09-1820-EL-ATA and 09-0582-EL-EEC, respectively, were included and reflect pricing subsequently approved in those cases.
- (4) The Commission has reviewed the proposed tariffs and finds that the tariffs comply with the August 25, 2010, Opinion and Order.
- (5) The tariffs filed May 10, 2011, should be approved. The tariffs should become effective on a service-rendered basis beginning June 1, 2011.

It is, therefore,

ORDERED, That the proposed tariffs shall be approved and be made effective on a services-rendered basis beginning June 1, 2011. It is further,

ORDERED, That the Applicant is authorized to file in final form four complete copies of tariffs consistent with this Finding and Order. Applicants shall file one copy in its TRF dockets (or make such filing electronically as directed in Case No. 06-900-AU-WVR) and one copy in this case docket. The remaining two copies shall be designated for distribution to the Rates and Tariffs, Energy and Water Division of the Commission's Utilities Department. It is further,

ORDERED, That the Applicants shall notify all affected customers via a bill message or via a bill insert within 60 days of the effective date of the tariffs. A copy of the customer notice shall immediately be submitted to the Commission's Service Monitoring and Enforcement department, Reliability and Service Analysis Division. It is, further,

ORDERED, That nothing in this Finding and Order shall be binding upon this Commission in any future proceeding or investigation involving the justness or reasonableness of any rate, charge, rule or regulation. It is, further,

ORDERED, That a copy of this Finding and Order be served upon the Applicants and all parties of record.
