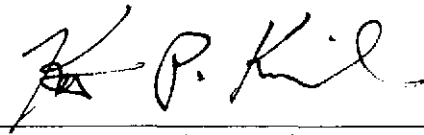

**CORRECTION TO MOTION FOR ADMISSION *PRO HAC VICE*
OF HOLLY RACHEL SMITH**

On March 16, 2011, Holly Rachel Smith filed a motion to appear *pro hac vice* before this Commission in the above-captioned proceeding on behalf of Wal-Mart Stores East, LP and Sam's East, Inc. (collectively, "Walmart"). This notice of correction is intended to clarify Ms. Smith's participation is limited to Case No. 11-346-EL-SSO.

In preparing the documents, Ms. Smith reproduced the caption AEP-Ohio used when it filed four cases as a "single company filing" and thus inadvertently listed all four dockets that AEP-Ohio associated with Case No. 11-346-EL-SSO. Initially, it appeared as if these four dockets would be consolidated into a single proceeding, however, this has not occurred to date despite outstanding requests. Moreover, the Commission has associated all four cases together in its Docketing Information System. Because the Ohio Supreme Court limits an out-of-state attorney's number of *pro hac vice* appearances in Ohio to three per annum (*See* Gov Bar. R. XII), Ms. Smith's inclusion of all four case numbers in making the initial filing is material to this tribunal's adherence to the Supreme Court rules. As such, this filing is to correct motion for admission (filed March 16) to reflect that Ms. Smith's request for admission is limited to Case

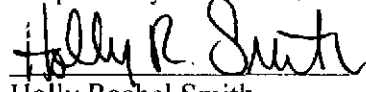
No. 11-346-EL-SSO. Although Ms. Smith was initially retained only for Case No. 11-346-EL-SSO, Walmart is not choosing to limit its participation. Walmart shall remain in all four dockets and associated Ohio counsel, Kenneth P Kreider, shall remain as an attorney of record and now lead counsel for Walmart in Case Nos. 11-348-EL-SSO, 11-349-EL-AAM, and 11-350-EL-AAM.

Additionally, please note that the Commission's Docketing Information System contains the incorrect firm name for Holly Rachel Smith. Ms. Smith practices with the law firm of Holly Rachel Smith, PLLC.

WHEREFORE, Holly Rachel Smith, respectfully corrects her motion for admission *pro hac vice* to appear before the Commission to clarify that the request is limited to Case No. 11-346-EL-SSO.

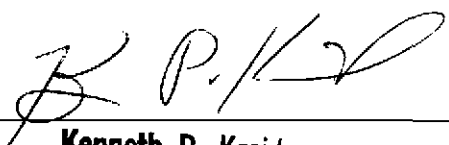
