On July 25, 2011, the Office of the Ohio Consumers' Counsel ("OCC") filed the Direct Testimony of Anthony J. Yankel in the above-referenced proceedings. Today OCC discovered that Exhibit AJY-A to Mr. Yankel's testimony was inadvertently omitted from the filing.

The omitted Exhibit is being filed with this letter.
