STATUS OF ISSUE RESOLUTION**



On May 9, 2011, the Attorney Examiner issued an Entry in Case No. 11-2776-GA-RDR in which she established, *inter alia*, a deadline of August 4, 2011, by which Vectren Energy Delivery of Ohio, Inc. ("VEDO"), is to file a statement informing the Commission whether the issues raised in the comments filed by the Staff of the Public Utilities Commission of Ohio ("Staff") and Office of the Ohio Consumers' Counsel ("OCC") on July 29, 2011 have been resolved.

VEDO, the Staff, and OCC have reviewed and discussed the issues raised in the comments. At this time, the issue raised by Staff has been resolved. VEDO believes that some, if not all, of the issues raised by OCC may be able to be resolved.

VEDO intends to continue discussion with OCC and Staff of the issues not yet resolved in the next few business days with the hope and intent of resolving all issues raised in these proceedings.
