#### **CONSTRUCTION NOTICE**

In accordance with Ohio Administrative Code Section 4906-11-02 <u>Construction</u> <u>Notice Requirements</u>, American Electric Power submits the following information:

#### 4906-11-02(B)

#### (1) <u>Name of the Project</u>

The name of this project is the Poston - Ross 138kV Line Reconductor/Rebuild Project.

#### (2) <u>Description of this Project</u>

American Electric Power must reconductor an existing 138 kV single circuit transmission line in Southern Ohio. The existing 3)636,000 cm ACSR (Aluminum Conductor Steel Reinforced) 26/7 strand conductor will be replaced with 3)1,033,500 cm ACSR (Aluminum Conductor Steel Reinforced) 54/7 strand conductor between Poston and Ross stations covering 43 miles. No additional right of way easements will be required for this reconductoring project. This project meets the requirements of a Construction Notice as stated in Rule 4906-1-01 Appendix A, Item 3. Replacing conductors on existing conductors with larger conductors.

#### (3) <u>Need</u>

Due to increasing electrical load growth in the Southern Ohio area, American Electric Power must reconductor an existing 138 kV single circuit transmission line. Due to deterioration and increased structure loading, existing structures will be replaced one for one with like structures throughout the project.

#### (4) <u>Construction Schedule</u>

This reconductoring project is expected to begin in late August 2011 and be completed and placed in service in December 2015.

#### (5) Estimated Cost

The cost for this project is estimated to be \$23,196,000.

#### (6) <u>Technical Features</u>


The existing 3) 636,000 ACSR (Aluminum Conductor Steel Reinforced) 26/7 strand conductors have a diameter of 0.990" and a weight of 0.874 lb/ft. These conductors will be replaced with 3) 1,033,500 cm ACSR (Aluminum Conductor Steel Reinforced) 54/7 strand conductors having a diameter of 1.245" and a weight of 1.330#/ft. The existing structures will be checked to AEP and NESC standards and replaced on a one for one basis to meet current clearance and load design. Highway crossing permits will be obtained from the Ohio Department of Transportation for all crossings. A SWPPP permit will be filed for this project with the Environmental Protection Agency.

#### (7) <u>Maps</u>

The line is located in Southeast Ohio. It starts at Poston Station located on Poston Road in Athens, Ohio. The Project then travels 43 miles East to Ross Station. Ross Station is located on Watt Street in Chillicothe Ohio just south of the Scioto River.
