## ENTRY

The Commission finds:

- (1) On January 19, 2011, the Commission issued an Entry in this case directing all telephone companies to make changes to their tariffs in accordance with Section 4927.15, Revised Code, and Rule 4901:1-6-11, Ohio Administrative Code (O.A.C.). In its Entry of January 19, 2011, the Commission recognized that tariff changes are necessary as a result of the adoption of the new retail rules. For example, tariff changes not otherwise affected by detariffing include, but are not limited to, Rule 4901:1-6-11(B), O.A.C., Tariffing Requirements. This rule requires the tariffing of all services found in Rule 4901:1-6-11(A)(1), O.A.C., to the extent that those services are provided by a telephone company. The Commission expects that such tariff changes, where applicable, will also be included in the detariffing applications.
- (2) Subsequently, an attorney examiner's entry was issued on April 7, 2011, reminding telephone companies that pursuant to Rule 4901:1-6-11, O.A.C., all telephone companies shall make changes to their tariffs as a result of the adoption of the new retail rules. The attorney examiner highlighted the fact that the requisite detariffing applications were to be filed by May 19, 2011, for the telephone companies that offer basic local exchange service, as defined in Section 4927.01, Revised Code, and April 19, 2011, for all other telephone companies.
- (3) This Entry serves as a final reminder to the telephone companies listed on the appendix to this Entry that have failed to file their detariffing applications. Such telephone companies shall have until no later than September 16, 2011, to file their detariffing applications with the Commission.

It is, therefore,


ORDERED, That, consistent with the findings above, each telephone company set forth on the appendix to this Entry shall file their detariffing applications with the Commission, no later than September 16, 2011. It is, further,




