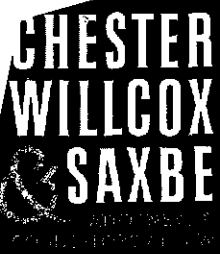



## **LEGAL NOTICE**

Notice is given that Aqua Ohio, Inc. ("Aqua"), 6650 South Avenue, Boardman, Ohio 44512, has filed an application with the Public Utilities Commission of Ohio (Case No. 11-4674-WWW-AAC) requesting authority to amend its certificate of public convenience and necessity to include additional territory in Summit County, Ohio ("Application"). According to the Application, Aqua seeks authority to extend mains and distribution lines within the municipal boundaries of New Franklin, Ohio.

If the Commission grants the Application, when and if service is commenced, the customers in the proposed service area will be charged the same rates as are charged to the company's customers in its Stark Regional Division, found in Section 4 of the Stark Regional Tariff, Revised Sheets Number 1, 2, and 3. The rules, regulations and other miscellaneous charges contained in the company's tariff, Stark Regional Division Tariff P.U.C.O. No. 1, on file with the Commission will also apply.
