APPLICATION

By this application Wisecarver Environmental Inc. ("Wisecarver" or "Applicant") seeks authority to terminate operations as a sewage treatment public utility. To effectuate this termination, Wisecarver respectfully requests that the Commission approve a substitution of sewage treatment service, cancel its Certificate of Public Convenience and Necessity No. 44 (Sewage), and authorize withdrawal of its current sewer tariff, PUCO No. 1.

In support of its application, Wisecarver states as follows:

Wisecarver is an Ohio limited liability company engaged in the business of providing sewage disposal service to three (3) customers by Special Arrangements. Such special arrangements were approved by the Public Utilities Commission of Ohio (Commission) in Case No. 04-543-ST-ACE.

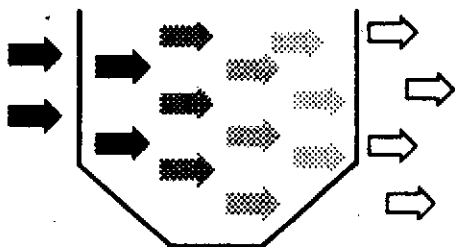
As a public utility as defined in Section 4905.02, Revised Code, and a sewage disposal company as defined in Section 4905.03(A)(13), Revised Code, Wisecarver is subject to the jurisdiction of this Commission pursuant to Sections 4905.04, 4905.05, and 4905.06, Revised Code.

The sewage treatment plant ceased operation in September 2010. The users of the sewage plant connected to the newly expanded Muskingum County sewer system as required. The manholes leading to the treatment plant have been filled with concrete and the treatment plant is currently being demolished as per Ohio EPA rules.

For the above stated reasons Wisecarver is requesting that the Commission cancel its Certification of Public Convenience and Necessity and release it from its jurisdiction.
