SECTION 1 – MISCELLANEOUS SERVICES**1.1 Late Payment Charge**

A late payment charge of 1.50percent applies to each customer when the previous month's bill has not been paid in full, leaving an unpaid balance carried forward. The 150 percent charge is applied to the total unpaid amount carried forward and is included in the total amount due on the current bill. If payment for a current bill is received by the Company before the bill's due date, but for technical or other reasons the payment is not applied to the customer's account prior to the issuance of a subsequent bill, the customer shall not be liable for that portion of any unpaid balance attributable to a Late Payment Charge.

A customer shall not be liable for any Late Payment Charge applicable to a disputed portion of that customer's bill, so long as the customer pays the undisputed portion of the bill and enters into bona fide negotiations to resolve the dispute. Agencies of the Federal government are exempt from the Late Payment Charge.
