## CUSTOMER NOTICE

The Public Utilities Commission of Ohio (PUCO) has ordered additional “de-tariffing” of the services that Ohio Telecom provides you. This means that beginning on September 16, 2011, service descriptions and the terms and conditions for services that Ohio Telecom provides will no longer be on file at the PUCO.

This modification does not result in a change in the prices, terms, or conditions of those services to which you currently subscribe. Ohio Telecom must still provide you notice at least fifteen days in advance of rate increases, changes in terms and conditions and discontinuance of existing services.

Since the information about Ohio Telecom’s services will no longer be on file with the PUCO, any agreement between you and Ohio Telecom will control new services or changes in service. For any new services or changes in service, it will be important that you carefully review and confirm the price, terms and conditions.
