

DESCRIPTION OF PROPOSED ADDITION TO SERVICE AREA**

Beginning at a point, said point being 600 feet east of the centerline of Rapp Road (C.H. 211) and the eastern boundary of Great Lot 11;

Thence northerly to a point, said point being 600 feet east of the centerline of Rapp Road and 600 feet north of the centerline of Calla Road (S.R. 630);

Thence easterly and parallel to Calla Road to a point, said point being located on the boundary line separating the States of Ohio and Pennsylvania and 600 feet north of the centerline of Calla Road;

Thence southerly along the boundary line separating the States of Ohio and Pennsylvania to a point, said point being located 600 feet south of the centerline of East South Range Road;

Thence westerly and parallel to the centerline of East South Range Road to a point, said point being approximately 2,700 feet west of western boundary line of Great Lot 22;

Thence northerly and parallel to said western boundary line of Great Lot 22 to a point 400 feet south of Snodes-Middletown Road (C.H. 28);

Thence westerly an approximate distance of 150 feet to a point, said point being the southwesterly corner of The Village of New Middletown;

Thence northerly crossing New Middletown and Calla Roads (C.H. 28 and C.H. 30) to a point 400 feet north of Calla Road;

Thence easterly and parallel to Calla Road and 400 feet northerly therefrom an approximate distance of 4,600 feet to a point, said point being 1,700 feet east of the western boundary of Great Lot 2 in Springfield Township;

Thence southerly and parallel to western boundary of said Great Lot 11 to a point, said point being 600 feet south of Calla Road (C.H. 30);

Thence easterly and parallel to said Calla Road approximately 4,200 feet to the point of beginning.
