
Re: Case Nos. 09-1947-EL-POR; 09-1942-EL-EEC; 09-580-EL-EEC

Pursuant to O.A.C. 4901:1-39-05(C)(2)(c), The Illuminating Company ("CEI" or "Company") is seeking written Staff approval to reallocate \$750,000 of funds between programs serving the Small Enterprise customer class. The reallocation supports the goals of its approved 2010 – 2012 program portfolio plan and is less than 25% of the \$21,655,351 Small Enterprise class budget approved by the Commission in cases 09-1947-EL-POR, 09-1942-EL-EEC, and 09-580-EL-EEC. This request does not expand the total budget for this customer class, nor that of the Company's approved portfolio plan.

Specifically, this reallocation seeks to shift \$750,000 within the Small Enterprise customer class from its *Small Enterprise Audits & C/I Equipment* and *C/I New Construction* Programs to its *C/I Equipment Program (Commercial Lighting)*. This program adjustment is reasonable and better positions the Company to achieve its 2011-2012 energy efficiency and peak demand reduction targets in a cost effective manner. The Company's *C/I Equipment (Commercial Lighting)* program has proven extremely popular with customers. Since launching this program in March 2011, incoming applications have already exceeded the program's 3 year budget. The Company projects customer demand for this program to continue and anticipates that these additional funds will be exhausted during the portfolio plan period. Further, the Company projects that the customer demand for its *Small Enterprise Audits & C/I Equipment* and *C/I New Construction* Programs in 2011 and 2012 will fall below the originally anticipated levels, thus allowing these funds to be shifted and better utilized within the Company's overall portfolio.

In light of these facts, the Company respectfully requests Staff's written approval to reallocate funds as described herein and as shown in Attachment A.
