In accordance with Rule 4906-1-11, American Transmission Systems, Incorporated ("ATSI"), transmit one (1) original and eleven (11) copies of the enclosed Letter of Notification for the above captioned project. In this Project, American Transmission Systems, Incorporated ("ATSI"), a FirstEnergy Corp. subsidiary, is proposing to install a capacitor bank addition at the existing Lime City Substation. To connect the proposed capacitor bank addition to the existing Lime City Substation, two (2) wood pole structures will be installed. Two (2) additional structures are proposed to be installed in order to hang static wires over the proposed capacitor bank addition.
