Thank you for contacting the Ohio Power Siting Board regarding American Transmission Systems, Incorporated (ATSI) / First Energy' proposed East Springfield-London-Tangy 138 kV Electric Transmission Line project. The OPSB's mission is to support sound energy policies that provide for the installation of energy and transmission infrastructure for the benefit of the Ohio citizens, while promoting the state's economic interests and protecting the environment and land use.

In compliance with Section 4906-05-08(A) of the Ohio Administrative Code, ATSI / First Energy held public meetings along the area of the proposed projects to share information about the project and gather concerns from those who may be impacted by it.
