As a result of the 1-4-2012 rate increase, the tariffed rate for a residential network access line will increase by \$1.25, going from \$6.90. The Line Charge rate displayed on the bill, which includes the network access line rate, will reflect this increase and will change from \$7.95 to \$9.20. So, for flat rate local service, using rates in effect subsequent to 1-4-2012, the rate will be calculated and shown on the bill as follows:
