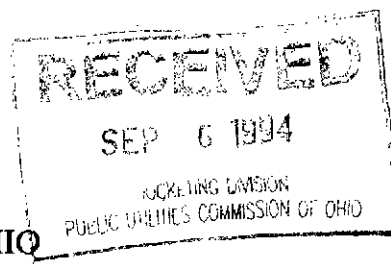

NOTICE OF INTENTION
TO PROVIDE REBUTTAL TESTIMONY

The Ohio Public Communications Association (OPCA) hereby provides notice that it will provide rebuttal testimony of Staff witness Roger G. Montgomery in these consolidated cases.

This rebuttal testimony will be offered by Don Wood, who testifies in this proceeding on Wednesday, September 7, and will address Mr. Montgomery's testimony concerning Staff's position on imputation and contract versus tariff rates. The details of the Staff's position on imputation were not set forth in the Staff Report, and therefore could not be addressed in Mr. Wood's initial testimony. OPCA desires to have Mr. Wood sponsor both

his direct and rebuttal testimony on Wednesday, September 7 in order to expedite this proceeding and avoid additional costs of bringing Mr. Wood back a second time.

A copy of Mr. Wood's rebuttal testimony is attached.

The OPCA will be prejudiced unless given the opportunity to place additional evidence into the record to rebut certain aspects of Mr. Montgomery's testimony.

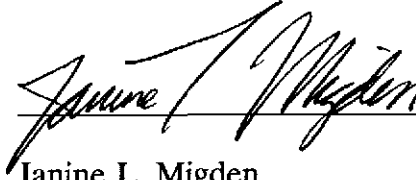
