#### **EXHIBIT C**

The Applicant, Kalida Telephone Company, Inc., hereby seeks approval to integrate its touch-tone rates into its basic access line rates. By doing so, the Applicant will eliminate a separate line item charge on customers' bills, which results in a simpler bill. Currently, a small number of the Applicant's customers (approximately 10-13) receive digital touch-tone rather than rotary dial service, but are not being charged for the touch-tone services. Given the changes in technology, touch-tone service is no longer an optional feature. Pursuant to Ohio Revised Code 4927.01, touch-tone dialing service is included within the definition of basic local exchange service; therefore it is appropriate for the separate touch-tone rate to be included in the basic local exchange service rate for all customers.

Effective with the April bill, the charge for touch-tone service will be included in the monthly basic access line rate for all customers. The vast majority of our customers will see no increase on their bills – the separate line item on the bill for touch-tone service will simply be eliminated and the charge included in the monthly exchange rate.

For the few customers who do not currently subscribe to touchtone, your monthly exchange rate will now include the \$1.50 for touch-tone service.
