COMPLAINT DESCRIPTION:

I am aware that PUCO suspended AEP's recent rate increase, especially as it applies to small businesses. I own a small retail business which operates stores in 3 shopping malls in Ohio. Our store at Ohio Valley Mall in St. Clairsville was hit particularly hard with these increases. We relocated within the mall to a similar sized space as we had before. We couldn't figure out why, but our demand charge in the new space averages 70 KW compared to average of 26 KW over previous 19 months in the old, similar space. My most recent bill dated 3-1-12 must reflect the

return to old rates because it went down to only 33KW and total \$ charges were half of the previous two bills. If it would help you understand how the rate increase impacted small businesses, I have my bills for this location detailed in an excel spreadsheet covering my payments from 2/23/10 to 3/23/12. I would be happy to email that but didn't know how to attach to this form.

right. We called and were told that Columbus Southern and Ohio Power merged to make a more level playing field for all the customers under AEP management. Too many Columbus Southern customers were paying a penalty for power and this change is supposed to make life better for everyone. Well, we think different. As we see it, our bill increased 217% (adjusted for KW usage) with no true warning or accountability for the increases. We were told to go to the website and look at our classification and that would explain everything. All the riders, service funds and cost recovery rates spelled out on their website spreadsheet works out perfect to the bill. It did not explain ANYTHING> It just confimed the new costs and the rate they are applied at - no explanation. The problem is that the people in charge that should be watching the cost structure in real time, seeing the bills stack up, maintenance and repair, replacement equipment, innefficiency, etc. and not enough coming in - evidently were not..... the Mangers, Accountants, CFO, COO and CEO and anyone else in authority need to be fired as we see it. They play too much golf. There is no way that all of a sudden these costs that were evidently missed or miscalculated are now on the books for consumers to swallow. It is plain and simple - THEY WERE NOT DOING THEIR JOB and when you do not do your job, you get fired and replaced with someone that can> the business MUST survive. WE can see a cost increase of 5, 7, 10 even 15% across the board to make up for lost revenue or cost increases including R and D on their side because of the outdated grid, fines, plant upgrades, weather problems and everything else that goes into power generation. My god, they do run a business - I think!!!!! and they have meetings, reports and graphs and consultants and no one saw this coming???? Anything above that we feel is just plain MISMANAGEMENT. As a small business, we could not go to one of our customers and all of a sudden tell them starting April 1st, we are going to raise the cost of your part by 217%. They would say - have the tool skidded and banded, we're coming to pick it up!!!!!!!!! End of story. They will never understand how it got that far out of whack - nor would they care. They will find a new supplier that will provide them with the service and delivery that they expect and we are out of business..... We understand that the Power Company gives you data and you judge by those numbers as to what will be allowed by law. There is just no way that this is fair and equitable and I'm sure that there are alot of other customers in the same boat as we are and we have NO PLACE TO GO. We are a \$750000/1 Million dollar a year company and to add that kind of direct overhead will kill us. To have to generate an additional \$200000,00 per year in sales to pay that extra \$1500.00 per month is right now almost impossible (and it needs to be right now). If we don't pay the bill, AEP will pull the meter and we are DONE. Please review and let us know your thoughts..... Thank You for you time to review. Pat Nolan

AEP has fully embraced the state's decision to move to electricity competition and is prepared to move forward through a fair and reasonable transition much like other utilities did. During the last decade, with the support and encouragement of the PUCO, AEP Ohio committed its low-cost power plants to serve our customers and avoided implementing higher market rates. That commitment cannot be changed overnight and will last three years into the future. Now competitors, most of whom don't have investments in Ohio and many who own no assets at all,

want to use AEP Ohio's plants to serve our customers using an arbitrary price as a basis for paying for the use of those plants. This price is extremely low, would have severe and immediate financial consequences for AEP, and could lead to unstable conditions for future investment in Ohio.

To have a healthy competitive environment in any industry, more than one company needs to be capable of competing on a level playing field. I'm writing to request that the PUCO reconsider its decision on the AEP rate case. Forcing AEP to sell power into the wholesale market at a loss is not what the PUCO had intended, I understand that, but there needs to be quick and fair action to ensure the best interests of Ohio consumers are met. Others should not be able to use AEP's assets for a profit while AEP is left with the bill; this is not reasonable. Some will argue that AEP was not complaining when rates were more favorable, which is true. However, others still could have competed with AEP to

supply customers; others were not forced to operate at a loss to supply AEP's customers. Now, the market is not equitable. Any company that would lose money upon operation would immediately stop operation, but AEP does not have that luxury. The lights must stay on, and for providing that service, AEP should be compensated. Forcing a company to lose money is, well, wrong. I trust that the PUCO understands this and will remedy the situation, but I am disappointed that Ohio consumers are unaware of the consequences of their animosity towards AEP. There are worse things than having AEP in Ohio (losing to Michigan ten years in a row and having 5' of snow in a two-day period are two examples that come to mind), and I would like the PUCO and AEP to both keep that in mind during the coming months. AEP has its problems, but First Energy is no model citizen. They do, however, both represent significant forces that maintain a competitive balance in Ohio. Please do not allow one of them to undercut the other; please set the capacity charge that alternative suppliers must pay to use AEP's generating assets at \$255/MW day until a final Electric Security Plan has been approved. AEP has provided low rates for a substantial amount of time because it opted to stay regulated and to protect its customers. First Energy, on the other hand, allowed a blackout due to a mistake on its system. I understand that small businesses are upset with the rates; my folks own a convenience store and were not too thrilled to see their latest electricity bill, to say the least. I also understand that large customers have been subsidizing small businesses for years, and at some point, enough is enough. Please work with AEP to develop a plan to allow a more moderate transition in electricity costs. Small businesses should pay their fair share, but we should provide them with more time to do so. The PUCO's decision will have far-reaching impacts, so please error on the side of completing the deal.

A competitive electricity marketplace in Ohio requires as many strong electricity suppliers as possible. A market in which one player has an advantage is not in the best interests of customers.

At present, one of the state's major electricity suppliers, American Electric Power, is in a particularly vulnerable competitive position because of the recent revocation of its rate plan by the Public Utilities Commission of Ohio. Without action by the PUCO to give AEP the breathing space and rates it needs to continue to do business, electricity competition in the state could be harmed for years to come.

For a decade, Ohio's electric utilities have been transitioning away from a highly regulated marketplace for electricity toward a competitive market system. That transition is incomplete, with some utilities further along in the process than others. AEP is not as far along as, for example, FirstEnergy, one of its primary competitors.

Until a few days ago, AEP was operating under a new rate plan designed to help it transition to market competition in four years. That plan, which went into effect in December, imposed sharp rate increases on small businesses, schools, churches and some homeowners, leading to more than 1,000 complaints to the PUCO. In an unprecedented move, the PUCO simply revoked the rate plan and announced that a new plan would have to be devised, a process that could take the better part of a year.

Not surprisingly, AEP officials felt that the rug had been pulled out from under them. Their planning for years to come was based on the terms of the now-revoked rate plan.

In response, AEP has asked that the PUCO allow it to raise the rate that its competitors are charged to make use of AEP's infrastructure. This rate, called the capacity charge, is what AEP is allowed to charge its competitors for the use of AEP's infrastructure when an AEP customer decides to switch to a competing power company. At present, the capacity charge is lower than AEP's cost to provide the electricity, resulting in a financial hemorrhage for AEP and a gift to its competitors.

The company has warned that unless such losses are stemmed, it could result in job cuts among the 7,000 Ohioans who work for the company.

Also, without the capacity-charge increase, AEP's competitors will be able to make deep inroads into the company's customer base, so that even after AEP completes the transition to a market-based system, it will do so with diminished strength that will make it a less effective competitor in the future. Less competition is bad news for Ohio's electricity users.

At some point soon, AEP will have to sink or swim on its own in a competitive electricity market. But the crisis it now faces is not the result of fair competition.

The PUCO should take the steps necessary to allow AEP to hold its own against competitors until a new rate plan is agreed upon.

Now competitors, most of whom don't have investments in Ohio and many who own no assets at all, want to use AEP Ohio's plants to serve their customers using an arbitrary price as a basis for paying for the use of those plants. This price is extremely low, would have severe and immediate financial consequences for AEP, and could lead to unstable conditions for future investment in Ohio.

To have a healthy competitive environment in any industry, more than one company needs to be capable of competing on a level playing field. Without a reasonable transition to a fair competitive framework, Ohio's economic recovery is not sustainable due to uncertainty for investors, and long term price instability for electric service.

I do believe that competitive electricity markets can work for Ohio. I ask for a fair transition to market that includes regulatory certainty so that all Ohioans can be successful. AEP Ohio will file a modified Electric Security Plan (ESP) with the PUCO by the end of March that will outline a path toward this goal.

On February 27, AEP Ohio filed a motion for relief and expedited action with the PUCO to halt the financial losses sustained as a result of the Commission's decision on February 23 to revoke its approval of the company's ESP plan, which the Commission had approved on December 14 and modified on January 23. AEP has requested that the Commission set the capacity charge that alternative suppliers must pay to use AEP's generating assets at \$255/MWday until a final ESP has been approved.

I believe this is important to fair competition in Ohio and request PUCO approve AEP's request immediately.

I write you as a lifelong Ohioan who has had the good fortune to be employed by American Electric Power, a great American company headquartered in Columbus, Ohio. During my time with AEP I have served our customers faithfully, interacted with Commission staff honestly, and

analyzed the state of our business prudently with the goal of balancing the needs of our customers, regulators, shareholders, and employees so that in the end we could all benefit from the generation and delivery of reliable, low-cost electricity, a staple of modern life. I am deeply concerned that the Commission's decision to reject AEP Ohio's stipulation agreement may lead to a situation in which I will have to choose between a community I have called home for thirty-two years and an employer that has provided me with the opportunity to serve our customers in the state of Ohio for the last eight years. I know that my job will likely move to another state if the Commission does not see fit to provide a workable solution for the RPM set-aside quandary we find ourselves in today, and that I will need to choose between moving with that job and looking for another. I also know that literally hundreds, if not thousands, of my friends and colleagues who serve Ohio customers directly will find themselves without employment. Worst of all, I know that allowing our competitors to benefit from what amounts to an unearned subsidy stemming from the RPM pricing model will impair AEP's ability to compete in the future, unjustly hampering consumers with higher costs and benefiting firms that may not even own generating assets within Ohio.

I implore the Commission to grant AEP's request to set the capacity charge at \$255/MW day immediately so that we may avoid further unreasonable losses. I further ask that the Commission grant AEP's motion for relief and expedited action immediately.

At the end of the day the Commission's main responsibility is to those who consume utility services in the state of Ohio. I submit that Ohio consumers will be irreparably damaged if AEP's ability to compete is impaired and its Ohio headcount reduced. I have faith that the Commission will rule wisely in a manner that will best serve the interests of Ohio consumers. Thank you for your consideration.
