The Ohio Telecom Association ("OTA") hereby respectfully moves the Public Utilities Commission of Ohio ("Commission"), pursuant to Section 4903.221, Revised Code, and Rule 4901-1-11, Ohio Administrative Code, for leave to intervene in the above-captioned matter with the full powers and rights granted by the Commission, specifically by statute or by the provisions of the Ohio Administrative Code, to intervening parties.

The OTA respectfully requests that it be permitted to participate in these proceedings so as to assert the protections afforded under Ohio law to the confidential information of its member wireless service providers whom are impacted in this matter.

As demonstrated further in the Memorandum in Support attached hereto and incorporated herein, OTA has a direct, real, and substantial interest in the issues and matters involved in the above-captioned proceeding, and is so situated that the disposition of this proceeding may, as a practical matter, impair or impede its ability to protect that interest. OTA believes that its participation will not unduly prolong or delay this proceeding and that it will significantly contribute to the full development and equitable resolution of the factual and other issues in the proceeding. The interests of OTA will not be adequately represented by other parties to the proceeding and, as such,

OTA is entitled to intervene with the full powers and rights granted by the Commission, specifically by statute and by the provisions of the Ohio Administrative Code, to intervening parties.
