COMMENT DESCRIPTION:

AEP has fully embraced the state's decision to move to electricity competition and is prepared to move forward through a fair and reasonable transition much like other utilities did. During the last decade, with the support and encouragement of the PUCO, AEP Ohio committed its low-cost power plants to serve our customers and avoided implementing higher market rates. That commitment cannot be changed overnight and will last three years into the future.

Now competitors, most of whom don't have investments in Ohio and many who own no assets at all, want to use AEP Ohio's plants to serve customers using an arbitrary price as a basis for paying for the use of those plants. This price is extremely low, would have severe and immediate financial consequences for AEP, and could lead to unstable conditions for future investment in Ohio.

To have a healthy competitive environment in any industry, more than one company needs to be capable of competing on a level playing field. Without a reasonable transition to a fair competitive framework, Ohio's economic recovery is not sustainable due to uncertainty for investors, and long term price instability for electric service.

I believe competitive electricity markets can work for Ohio. AEP has asked for a fair transition to market that includes regulatory certainty so all Ohioans can be successful. On February 27, AEP Ohio filed a motion for relief and expedited action with the PUCO to halt financial losses sustained as a result of the Commission's decision on February 23 to revoke its approval of the company's ESP plan, which the Commission had approved on December 14 and modified on January 23. AEP has requested that the Commission set the capacity charge alternative suppliers must pay to use AEP's generating assets at \$255/MWday until a final ESP has been approved.

Please take immediate and favorable action on AEP Ohio's petition.



Hello,

Please docket these comments in case numbers 11-346-EL-SSO & 11-348-EL-SSO.

I am writing with regard to the recent PUCO reversal of AEP's plan which they submitted to

enable them to compete fairly in Ohio.

Jobs are at risk with whichever choice is made. The same small business owners who will suffer when their electric rates go up to a fair level are the same small businesses who will suffer when the newly unemployed AEP workers can no longer patronize their businesses. With the rate reversal, AEP employees face unemployment due to unfair competition rules beyond their control. The PUCO case seems like a lose-lose situation regardless of which approach is taken.

The honorable, truthful, fair thing to do is that a company be allowed to charge a fair price for its product. Your unprecedented reversal which hamstring AEP made you look foolish. Either you must allow fair practices for both consumer and supplier and face the heat for your decision or you will cause Ohio to spiral downward because companies cannot fairly compete. Eventually, one way or another, the consumer WILL end up paying a fair rate. If AEP is gone and there is no competition, then the surviving company which holds the monopoly will charge whatever rate they wish and no one can stop it.

I'm sure you've received emails with analogies of companies being unable to charge a price for their product which allows a profit. Why make a product if you can't make a profit? How can a company survive when they are FORCED to provide charity to other companies? Oh, yeah, I remember - that's called socialism. Wikipedia defines socialism as "an economic system characterized by social ownership or control of the means of production and cooperative management of the economy". So, you see, since you are telling AEP what they must charge and to whom, then YOU, as the PUCO, are social dictators over AEP, since you are controlling our economy unfairly.

You MUST allow fair competition. I understand that you are also tasked with protecting the consumer and that is certainly an honorable goal! But it is unwise to subsidize and promote unfair practices. (I wonder if you've promoted unfair business practices unknowingly? It seems if one business pays its fair cost for electricity but a competitor receives the subsidized rate then the first company has been effectively put down because of your rate management.)

AEP must be allowed to compete competitively and must be allowed to earn a profit.

There is simply no easy way for a company like AEP that has operated as a regulated utility for 100 years to transition to a competitive entity overnight. Other states that have transitioned from regulation to competition by allowing a recovery of legitimate invested generation costs. This is the intent of an MRO rate phase in or continuing an ESP rate while allowing some customers increased ability to switch. Not allowing this transition
