Please docket these comments in case numbers: 11-346-EL-SSO & 11-348-EL-SSO. I am writing to complain about the PUCO recent actions to rescind AEP's Electric Security Plan. This unprecedented action puts AEP in an untenable position. AEP is an extremely important company for Ohio and plays an integral part in the Ohio economy. AEP is also a good corporate citizen and has done a lot for Ohio. The PUCO's actions put AEP employee's jobs at risk by asking AEP to compete on an uneven playing field with other Electric providers. Any business

relies on a certain degree of stability in order to plan for the future and the recent rash actions by the PUCO has created dangerous instability for AEP, Ohio electric consumers and the Ohio economy in general. There is a real risk that if AEP is not treated fairly it will significantly decrease its presence in Ohio and I do not see how that would be good for Ohio. I understand the need to work towards a more market driven approach but this is something that needs to be worked towards in an orderly manner. Going quickly to a completely market driven model has risks for Ohio not just AEP as the result could be that AEP decides to sell most of its electricity to other states and suddenly there is a short supply of electricity in Ohio sending rates higher and potentially causing bigger problems for electric consumers. Please avoid this train wreck by approving AEP's request to set the capacity charge that suppliers outside of AEP must pay to the reasonable rate AEP requests until a final Electric Security Plan has been approved. Please act quickly as delay on this issue puts AEP in an unacceptable position when competing with other utilities for customers and basically asks AEP to let its competitors sell its product for less than it costs AEP to produce it.

I am an employee of AEP and would like to express my extreme dissatisfaction with the recent reversal of the agreement between PUCO and AEP regarding the rates and transition to an deregulated market place. We all understand the concern raised by small businesses from the

40% increase in electric rates, but that was the agreement. If the decision to reverse that agreement was made, an immediate agreement should be negotiated to either apply fair interim rates that will apply until a new settlement is reached or expedited negotiations to reach a new agreement as quickly as possible to supercede the old agreement. It sure appears that the decision reached by PUCO to simply reverse the old rates is the worst possible decision for AEP and in the long run, for AEP's customers. AEP stock took an immediate hit because of the PUCO decision and it doesn't change the fact that higher rates are justifiable and in particular, the arbitrary price charged to competitors to serve AEP customers at below cost is disturbing and anti-business. So, in summary, please take whatever action necessary to complete the negotiations with AEP and live up to your responsibility to apply fair rates that minimize the effect on AEP's customers while allowing AEP to recover the costs to generate and supply electricity in Ohio. The original and restored capacity charge applies to any competitive retail electric supplier ("CRES") serving customers in AEP-Ohio's area. More specifically, AEP-Ohio is allowed to impose a capacity charge of \$255 per megawatt day, whereas by June 2012, the "market" price for that capacity is set at \$16.50 per megawatt day. That represents a PREMIUM of ~1,445% over market!!! Setting the capacity charge at \$255 means suppliers must charge customers higher prices, which effectively ELIMINATES

shopping opportunities. In other words, no opportunity to shop; no opportunity to save; but you are extended the opportunity to remain a "captive" customer to AEP. The bottom-line is this ... AEP has no interest in competing, so what then was the purpose of deregulating Ohio's electricity market if the PUCO plans to enable AEP's anti-competitive behavior?

The PUCO's approval of AEP-Ohio's request to restore the capacity charge provides exceptions for some customers served through government aggregation programs, and while the PUCO's March 7, 2012 decision states the \$255 capacity fee will end on May 31, 2012 and be replaced by the market-based charges starting June 1, 2012, at this point, why should customers speculate whether or not the PUCO plans to change course again, by further extending the life of this anti-competitive charge?

The most egregious issue of all is that customers already "shopping" have been placed in financial harm's way, as they are now expected to pay a PREMIUM over AEP's SSO given the incremental capacity fees suppliers MUST pass-through to customers in order not to go BANKRUPT. So in the spirit of being crystal clear, the Commission is knowingly and intentionally harming customers who are behaving just as the Commission should expect them to behave; that being, pursue access to open-markets ... help competition develop in Ohio's deregulated electricity market ... and force suppliers to compete for serving your load.

And last but certainly not least. Based on the most recent rates filed by AEP (effective date of 3-9-12), School Districts will likely pay MORE than ever before. When a School District's Load Factor exceeds 43.5%, which is more often than not, their invoicing will EXCEED what they were expected to incur under AEP's ESP; so just when one might think the PUCO could not inflict incremental harm, the powers that be managed to do just that!

Again, I ask, when will our government begin working for the people? This is ridiculous that we continue to be subjected to monopolies in this day and age. It is even more egregious that our state's residents are being hit with this increase at their residence, and then being asked to more in tax to pay for these increases inflicted on their local governments. Enough is enough, years of telling AEP to roll back their profits, yet continually allowing them increases wrecks of something very wrong with the PUCO. Something needs to be done.
