At the same time, I feel that families that are over PIPP income requirements will suffer with increases to their electric service. I know families that set their heat in the winter at 50 or 60 and then layer themselves and their children in heavy clothing and blankets and still pay 200.00 or more a month in electric costs. Unemployment and people going back to work but taking significant pay cuts is a major issue in this area. I just worry that people who do not meet PIPP income guidelines but are still struggling and surviving paycheck to paycheck will be in for a long cold winter.
