## MOTION FOR PERMISSION TO APPEAR PRO HAC VICE INSTANTER BEFORE THE COMMISSION

Pursuant to Gov.Bar R. XII(2)(A)(6), Derek Shaffer, attorney for Ohio Power Company, hereby moves the Public Utilities Commission of Ohio (the "Commission") to grant him permission to appear *pro hac vice instanter* and participate as co-counsel in the above-captioned proceeding.
