Dear Ms. Jenkins:

In accordance with Ohio Administrative Code (OAC) §4906-11-02, Columbia Gas of Ohio, Inc. (Columbia) hereby transmits the enclosed proposed pipeline project known as the Columbus HP Casing Project.

The project area is located at the intersection of Dublin Road and Limestone Way. In addition, a second portion of the project is located between Alger Road and US 62 in Columbus, Franklin County, Ohio.

Please be advised of the following:

1. **Project Name:** Columbus HP Casing Project
2. **Project Description:** The proposed Columbus HP casing project includes installing approximately 700 feet of 20-inch at the intersection of Dublin Road and Limestone Way and 400 feet of 24" inch coated steel high pressure gas main near Alger Road and State Route 62 (maps attached).

This project meets the requirements of Construction Notice as it falls under "rerouting or extension or new gas transmission line and associated facilities, not greater than one mile in length." (OAC 4906-1-01, Appendix B).

3. **Project Need:** This project is a system betterment project required by Columbia Gas of Ohio.

4. **Schedule:** Construction is planned to start as early as May 1, 2012 with an expected end date of November 1, 2012.
5. **Capital Cost:** The capital cost of the Columbus HP Casing Project is approximately \$1,800,000.
6. **Operating Features:** MAOP 190 PSIG. All high pressure mains will be installed within private easement and existing public right-of-way. A map showing the pipeline route is attached.
7. **Map and Directions:** A USGS map of the project location is attached to this Construction Notice. In order to locate the first portion of the proposed site, take US 33 to Trabue Avenue and turn left for approximately 0.5 mile. Then turn right on to Dublin Road and go approximately 0.5 mile and Limestone Way is the second right. For the second site take I-670 East to US 62E and turn left onto North Stygler Road and then left onto Alger Road.

We have provided a copy of the Letter of Notification by certified mail, with return receipt requested, to each official of the political subdivisions immediately affected by the proposed project as listed in the attached Exhibit 1. Copies of the transmittal letters addressed to the local government representatives of the City of Columbus and Franklin County are enclosed for your file.


