I'm writing to express my concern for the handling of AEP's recently modified ESP and its associated filings, now before the commission. Since Ohio began deregulating the electric utility industry over 10 years ago, I feel that AEP has acted in a responsible manner, working with the commission and its staff to maintain reasonable electricity prices throughout this critical period.

At the request of the commission, AEP retained its regulated rate structure during this approximate 10-year period--one that included volatile natural gas prices and relatively strong economic development. To do so, AEP continued to invest in important generating assets that are now out-of-favor due to largely unforeseeable developments. For this reason, it's important for the commission to act appropriately by approving AEP's ESP for a fair and reasonable transition of its generating capacity.

Frankly, deregulation of the industry has not proven wholly successful in other states, such as California and Texas. The Ohio PUCO could learn a lot from these two states, alone. Most notable is the fact that both states have failed to adequately spur new generation development which either caused (in the case of California) or is predicted to cause (in Texas) power short-falls. In Ohio, other factors are at stake, as well. If AEP is treated unfairly by the commission, additional downside exists for the state, including the potential loss of AEP jobs.

So, again, I urge you to act in a manner that is fair and reasonable at this critical juncture and to approve AEP's modified ESP. Thank you.
