The Federal Communications Commission's ("FCC's) Report and Order and Further Notice of Proposed Rulemaking, FCC 11-161, released November 18, 2011, and Order on Reconsideration, FCC 11-189, released December 23, 2011, in *Connect America Fund et al.*, WC Docket No. 10-90 et al, establish bill-and-keep as the default compensation methodology for non-access traffic exchanged between local exchange carriers ("LECs") and Commercial Mobile Radio Service ("CMRS") providers, beginning July 1, 2012.

To the extent that this LEC-CMRS bill-and-keep provision remains in effect and is not modified or eliminated on reconsideration by the FCC or remanded or voided by a reviewing court, the Parties agree that the change of law provision in Section 17.0 of the Wireless Traffic Termination Agreement between the Parties requires the \$0.02 per minute terminating rate in Section 2.1 of the Agreement to be converted to bill-and-keep. Unless the FCC changes the effective date of its LEC-CMRS bill-and-keep provision subsequent to the date of Amendment No. 1 to the Agreement, the effective date of this change will be July 1, 2012.
