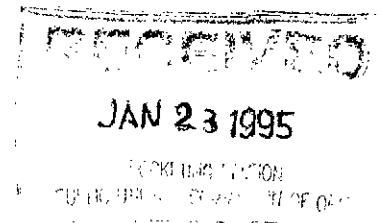

AMERITECH OHIO STATUS REPORT

---

Ameritech Ohio pursuant to the Commission's November 23, 1994 Opinion and Order ("Order") in this case files this status report concerning the meeting held between representatives of Mid East Telephone Answering Service Association ("METAS") and Ameritech Ohio. In the Commission's Order Ameritech Ohio was directed to meet with representatives of METAS and the Staff to discuss the cell classifications of certain central office optional line features and custom calling services under Ameritech Ohio's alternative regulation plan.<sup>1</sup>

On January 20, 1995 representatives of Ameritech Ohio, the Staff and METAS met by conference call as requested by the Order. The parties did not reach a resolution of the issues raised by METAS. However, the parties agreed to continue their discussions and to further explore several options raised at the meeting. The parties have agreed to meet again by February 3, 1995.

Ameritech Ohio will file another status report in order to keep the Commission informed of any progress within two weeks after the parties next meeting.
