Ohio Power Company (“OPCo” or the “Company”) discovered an error in its 2011 Annual Alternative Energy Compliance Plan Status Report filed in the above referenced docket on April 13, 2012 (“2011 Report”). OPCo inadvertently included in its 2011 Report 548 Non-Ohio, Non-Solar RECs that were utilized in OPCo’s 2009 Annual Alternative Energy Compliance Plan Status Report. To correct this error, OPCo will replace the subject 548 RECs with new RECs as detailed in the enclosed confidential attachment.

The attachment filed with this letter electronically is the public version of the attachment. The attachment contains confidential information relating to the source facility, amount and identification numbers of the replacement RECs. As it did with similar information contained in its 2011 Report, OPCo will file the confidential version of the attachment under seal accompanied by a motion for protective order according to Commission rules.
