MOTION FOR EXTENSION OF TIME


In an Entry issued on February 23, 2012, the Commission selected Exeter Associates, Inc. to conduct the management/performance portion of the audit and selected Goldenberg Schneider, LPA to conduct the financial portion of the audit. The Entry required both sets of auditors to comply with the terms of the request for proposals (RFP) issued on January 18, 2012. The timeline in the RFP required the auditors to submit draft audit reports to Staff by May 1, 2012 and to file their final audit reports by May 15, 2012. On May 1, 2012, the Attorney Examiner granted Staff's motion to extend the due date for the draft reports to June 1, 2012 and the due date for the final reports to June 15, 2012. Staff now requests that the due date for the final reports be extended to August 15, 2012. The reasons for this motion are set forth in the accompanying Memorandum in Support.

MEMORANDUM IN SUPPORT


Under the requirements of the RFP issued on January 18, 2012, the auditors were required to submit draft audit reports to the Commission Staff by May 1, 2012 and to file their final audit reports by May 15, 2012. In an Entry dated May 1, 2012, the Attorney Examiner granted Staff's motion that the auditors be granted an extension of time until June 1, 2012 to submit draft reports and to June 15, 2012 to file the final reports.

Staff will require additional time to review the draft reports that have been submitted. Therefore, Staff requests that the due date for the filing of the final reports be extended to August 15, 2012. Counsel for the other parties have stated that they will not oppose this request.


