Re: Complaint by Fred Rodgers against Columbus Gas

In December 2001 we began receiving computerized telephone messages asking us to return the call to an 800 number. Since the message did not identify the caller, we ignored the calls for several days. Finally we did return the call and learned that the calls were coming from a collection agency hired by Columbus Gas. Since we have lived in an all electric home since 1990, we felt there must be some mistake. We were asked to call customer service at Columbia Gas for additional information.

The service representative at Columbus Gas advised that they were attempting to collect a past-due gas bill of \$32.74 for service at 136-B East Lakeview Avenue. I owned the apartment building at 134-138 East Lakeview from 1969 until May 1999. The representative further advised that a tenant at 136-B had moved in 1990 and left a balance of approximately \$7.00. They are attempting to collect the original bill plus interest from me, because they say I signed an agreement to pay any outstanding tenant's gas bills. I cannot imagine that I would have signed such an agreement, but I told them to send me a copy with my signature on it and I would pay the bill immediately. After promises by them to do so, I still have not received a copy of the agreement.

I also asked the representative why they had not attempted to bill to me in the nine years between 1990 and 1999, when I sold the building. They were never able to give me an explanation, but simply stated that if I didn't pay the bill they would turn me over to collection. In my last conversation with Columbia Gas, I asked for valid evidence that I had signed a contract. The representative promised once again to send it and that was our last conversation. On around February 24, 2002, I received the attached notice from an attorney representing the Columbia Gas advising that legal action would be taken against me if I refused to pay the \$32.74 immediately.

It is my complaint that the charge is not my responsibility and I am concerned that Columbia Gas will ruin my credit over a bill that they have not proven I owe.
