If the proposed increase in capacity cost is approved, my electric supplier will be forced to increase my electricity costs. Please don't put the interest of AEP ahead of the interest of the residential customers of the State of Ohio.

Please take my view as a customer of a competitive service provider and a current citizen of the State of Ohio into consideration when making your decision in this matter.
