Noted below is my input to the ever increasing electric rates by FirstEnergy. First, I'd like to say I'm a former employee of the Illuminating Company, Centerior Energy and FirstEnergy. As an employee of

the Illuminating Company and Centerior Energy we enjoyed a 35% discount on our electric usage, this discount was over and above the discount for our "all electric service" with CEI (the all electric discount was promised, by CEI, as long as the house we purchase remained all electric). Shortly after Ohio Edison acquired (1997) Centerior Energy and created FirstEnergy, FirstEnergy terminated the 35% employee discount but retained the all electric discount for its customers and employees, a discount "because your usage warrants it".

We owned our all electric house at 20269 White Bark Drive (Strongsville) from December, 1983 until August, 2008. We decided that we wanted to downsize; so we purchased a second all electric home at 10794 Meadow Trail (Strongsville) in May, 2006, prior to purchasing we called FirstEnergy customer service and were told on four separate occasions, by four different customer service personnel, that the "all electric discount would always be in place as long as the property remained all electric". We feel deceived by FirstEnergy and the PUCO for letting this happen to what we consider a valid verbal contract for electric services at a discounted all electric rate!

Since these rate issues have developed, the selling prices of homes in our neighborhood have fallen by over 20 to 25%. These reductions have had significant negative impacts on our schools and public services! And today, the selling prices of our homes have dropped even further.

What is happening today is a prime example of corporate greed and a desire, by FirstEnergy, to continue record growth, profits and expansion of their corporate empires at the cost of those customers who depend on them as their primary electric service/utility provider. This is a utility that wants to be number one and doesn't care who it negatively impacts, they should not be able to continue to pass costs off to their customers!

We look to you and your staff to restore, permanently modify and not allow perceived costs to be based along to it's customers. It's time for the PUCO and the Ohio Consumers Council to step up and become "watch dogs" and advocates for all Ohio residents.

In 2010, I had testified before members of PUCO (along with hundreds of other all-electric homeowners) against First Energy's sudden and surprise announcement that they were unilaterally terminating all-electric home discounts. At that time, First Energy was threatening to remove our promised life-time discount for all-electric homeowners. The outcome of all that testimony was a FAILURE: we simply received a reduced discount which was and is to be phased out over 4 or 5 years.

In the meantime, we've been forced to continuously review and evaluate new options including switching to gas (an extremely expensive proposition which is impractical) and seeking our electricity from other suppliers. The latter requires continuous review and expense. In just one year, I've switched into 2 different plans that cost me just under \$100 in cancellation fees. They shouldn't have to constantly be looking over their backs for a better deal.

AND NOW, FIRST ENERGY IS AT IT AGAIN! Now, First Energy is attempting to hurt us through their new rate request on the distribution side of the house. These proposed increases severely and unfairly impact all-electric homeowners. And for those of us who are retired and on fixed incomes, this First Energy action is extremely hurtful.
