

Dear Mr. Snitchler:

I received a letter from Boarder Energy with a suggested letter of advocacy meant for me to sign and send to you regarding Case 10-2929. An addressed envelope was included, with postage, of which I'm taking advantage in order to send you this letter.

I visited the Internet web sites for Border Energy, American Electric Power, and your own Commission's web site to seek more information about this issue, and yesterday I read an opinion column about it in the Columbus *Dispatch*. I believe I have the beginnings of an understanding; enough to know it has history and is complex. Border Energy's web site offered no information. AEP's web site offered background, but left me with more questions than answers, and I expect their viewpoint will favor their own cause. The *Dispatch* column I pretty much dismiss as I have the impression the editorial board is pretty much against causes that will change or challenge. I have to note the PUCO web site gave me nothing as it can be difficult to navigate and while I was able to find a page with the numbers 10-2929 on it, I could get no further information, or it wasn't clear how to.

Consequently, this letter is one of advocacy not for Boarders Energy, First Energy, or AEP. It is a letter of advocacy for me, a retired citizen on a fixed income who has no choice but to pull my fiscal belt tighter and tighter as rent, electric, water, sanitation, telephone, and for sure, health care costs increase. I understand the economics of inflation and related costs of doing business, and while I am most grateful for the income I have, I fully understand what it means when I see the relatively small amount of discretionary income I have diminish each year. I worked hard all my life, was fortunate to receive a good education, will turn 70 this year and anticipate about 20 more years in this life. At no time have I needed public assistance and I never want to. Please take me, and the many, many, other people like me into consideration as you make a decision on this issue.
