Dear Mr. Joseph,

Staff attended your July 12, 2012 pre-construction conference for the portion of work related to site grading (herein referred to as Phase I) for the Vassell Substation project located in Delaware County. Staff has reviewed and approves information provided that is pertinent to Phase I of construction; including engineering drawings for the preferred site, AEP's complaint resolution procedure, landscaping and lighting, access, environmental specialist information, transportation and stormwater permits, erosion and sediment control measures, hours of construction activity, and site layout at the project access point. Staff finds that the OPSB Board's conditions for Phase I of the project related to these items have been adequately addressed. As such, grading construction may now commence on the site with one exception: as agreed at the preconstruction conference, the northwest property screening berm will not be constructed until further notice, and no earthmoving will commence in the northwest portion of the site until additional archaeological testing has been concluded to the satisfaction of Staff.

Attached for reference and coordination is a list of the studies, plans, and responses Staff has received to date for this project. Staff will attend a separate pre-construction conference at your future scheduling to specifically address issues associated with Phases II-V of this project (transmission line work, foundations, riparian clearing, above-grade work, etc.).

Staff looks forward to working with AEP and its contractors on this project as it moves forward. Please update Staff weekly as Phase I progresses and please notify the Board when construction is completed and when the facility is eventually placed in service. Please also note that Staff will periodically be on-site throughout construction of this project, and will check in at the main
