In accordance with Ohio Administrative Code (OAC) §4906-11-02, Columbia Gas of Ohio, Inc. (Columbia) hereby transmits the enclosed proposed pipeline project known as the Holland Sylvania Road Project.

The project location is on the southeast corner of Holland Sylvania Road W. Sylvania Avenue in Sylvania Township, Lucas County, Ohio and proposes replacing approximately 285 feet of 20-inch coated steel high pressure gas main and 106' of 6-inch coated steel high pressure gas main

Please be advised of the following:

- 1. **Project Name**: Holland Sylvania Road Project
- 2. Project Description: This project is a condition replacement project initiated by Columbia which has an existing 20-inch coated steel high pressure gas main on the east side of Holland Sylvania Road on the southeast corner of W. Sylvania Avenue. The existing 20-inch coated steel high pressure gas main has a segment which is covered with concrete and has been identified by Columbia Corrosion personnel for replacement. The proposed 20-inch coated steel high pressure gas main will be installed primarily within a proposed Columbia pipeline easement. A drawing of the proposed work by Columbia is included with this submission.

This project meets the requirements of a Construction Notice at it falls under "rerouting or extension or new gas transmission line and associated facilities, not greater than one mile in length." (OAC 4906-1-01, Appendix B).

- 3. **Project Need:** This is a condition replacement project initiated by Columbia.
- 4. **Schedule:** Construction is planned to start approximately September 4, 2012 with an expected end date of October 15, 2012.
- 5. **Capital Cost:** The capital cost of the project is estimated at \$954,356. The entire project will be funded by Columbia.

6. **Operating Features:** The proposed project includes the installation of the following facilities:

The 20-inch coated steel high pressure main is anticipated to be installed within a proposed Columbia easement. The 6-inch coated steel high pressure main as well as two 20-inch tie-ins will be installed within the public right of way of Holland Sylvania Road and W. Central Avenue.

- 7. **Map and Directions:** A map of the project location is attached to this Construction Notice. In order to locate the proposed site, take US 23 North to Ohio 15 West. Take OH15 West to Interstate 75 North. Take exit *192, Interstate 475 US 30, North to exit *14 Interstate 475 East to exit *15 Corey Road. Turn left on Corey to W. Sylvania Avenue and turn left on W. Sylvania Avenue to Holland Sylvania Road. The project site is on the southeast corner of Holland Sylvania Road and W. Sylvania Avenue.
- **8. Property List of Additional Easements:** Columbia will be utilizing existing pipeline easements as well as securing new pipeline easements to construct this project.
