**MOTION FOR PERMISSION TO APPEAR
PRO HAC VICE OF SCOTT C. SOLBERG**

Pursuant to Rule 4901-1-08(B) of the Ohio Administrative Code, M. Howard Petricoff, an attorney licensed to practice in the State of Ohio, respectfully moves that Scott C. Solberg be admitted *pro hac vice* to practice before the Public Utilities Commission of Ohio (the “Commission”) for the purpose of representing Exelon Generation Company, LLC (“EGC”) in the instant matter, and in support thereof, states as follows:



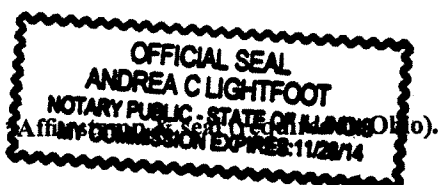
