MOTION TO SUSPEND THE PROCEDURAL SCHEDULE FILED ON BEHALF OF THE STAFF OF PUBLIC UTILITIES COMMISSION OF OHIO

On July 12, 2012, the Attorney Examiner issued an Entry that set the modified

procedural schedule as follows:

- (1) Testimony on behalf of interveners shall be filed by August 6, 2012
- (2) A prehearing conference shall be held on August 13, 2012, at 10:00 a.m.
- (3) Testimony on behalf of staff shall be filed by August 13, 2012.

(4) Discovery requests, except for notices of deposition, shall be served by August 13, 2012.

(5) The evidentiary hearing shall commence on August 27, 2012, at 10:00 a.m.

The Parties are continuing to have settlement discussions and need more time to review and analyze the various issues involved in this case. Thus, the Parties, including DP&L, request that the procedural schedule be suspended. The Parties will continue to attempt to reach a settlement and will notify the Attorney Examiner immediately if a stipulation is entered into. If, however, it becomes apparent to the Parties that settlement may not be possible, the Parties will notify the Attorney Examiner that the Parties have reached an impasse.

Counsel for Staff conferred with the Parties regarding this motion and none of the Parties object to the filing of this motion. In addition, as noted in the Attorney Examiner's July 12, 2012 Entry, DP&L previously waived the 90-day limit for Commission action on its first application for a market rate offer under Section 4928.142(B)(3), Revised Code.
