## **ENTRY**

The Attorney Examiner finds:

- (1) On July 18, 2012, the Commission issued an Opinion and Order in Case No. 12-1230-EL-SSO, in which the Commission ordered that the stipulation of the parties, as modified by the Commission, be adopted and approved.
- (2) As part of the stipulation, the Commission ordered Commission Staff (Staff) to hold a workshop in the newly opened five-year rule review for Chapter 4901:1-10, Ohio Administrative Code (O.A.C.), specifically for the purpose of reviewing FirstEnergy's implementation of the partial payment priority, including, but not limited to, implementation of the stipulation with respect to customers on deferred payment plans. At the conclusion of the workshop, Staff shall identify whether, in order to protect consumers, protect the financial integrity of the Companies, and promote competition in the Companies' service territories, amendments to Chapter 4901:1-10, O.A.C., are necessary, additional waivers of Chapter 4901:1-10, O.A.C., are necessary, modifications to FirstEnergy's tariffs or practices are necessary, or additional measures should be undertaken as recommended by Staff.
- (3) Interested stakeholders should come to the workshop prepared with necessary technical experts to provide appropriate feedback. After Staff has an opportunity to consider the feedback received at the workshop, proposed rule amendments may be issued by the Commission for comments and reply comments from interested stakeholders.
- (4) Accordingly, the Attorney Examiner finds that, at this time, a workshop should be scheduled for August 31, 2012, at 10:00 a.m., at the offices of the Commission, 180 East Broad Street, Hearing Room 11-B, Columbus, Ohio.
