Gentlemen:

The Ohio State Legislative Board, United Transportation Union, representing Ohio railroad employees wishes to file a weed and vegetation complaint (Ohio Administrative Codes 4901-5-05 and 4901-5-07) against CSX Transportation (CSXT), which railroad is subject to regulation under Chapters 4905 and 4907 of the Revised Code.

In conducting its railroad operation in the vicinity of Columbus, Franklin County, Ohio, at the CSX Columbus Terminal, located at 2600 Parsons Avenue, said company has permitted unsafe and hazardous conditions to arise due to the excessive growth of weeds and vegetation on its property at the following location:

At the west end of the New Yard in the Columbus Terminal:

12 New Yard: This track has weeds and vegetation in areas about three (3) car lengths to (5) car lengths off the New Yard Lead. Weeds and vegetation stand at least knee high and up to head high and growing in different degrees of thickness.

An attempt to correct these conditions was made two weeks ago by the engineering department. A gentleman came to the location and sprayed weed killer. He explained he could not cut the weeds with his weed whacker due to the thickness of the stems. Within 30 minutes of his spraying it rained for the next 3 hours. This made the effect of the weed killer diminished. Later in the day the gentleman returned and corrected the weed problem at another location, but did nothing else in 12 New Yard. These conditions have been pointed out to local management for weeks, but the weeds and vegetation have not been corrected. As of August 6, 2012, the weeds and vegetation are still standing.

By its failure to establish or maintain an adequate vegetation control program early in the season, it is now endangering the railroad employees required to use this area in the performance of their required duties.

It is requested that an investigation be conducted, under Section 4907.08, to determine if this railroad at the above location is in violation of your Commission's "Weed Order." If excessive growth is found, then an appropriate and timely order should be issued to require the elimination of the growth and the establishment of a vegetation control program to prevent the recurrence of such unsafe conditions.

No additional information was received.
