## ENTRY NUNC PRO TUNC

## The Commission finds:

- (1) On July 20, 2011, Duke Energy Ohio, Inc. (Duke) filed an application and supporting testimony, proposing the creation of an energy efficiency/peak-demand reduction rider to supplant its save-a-watt rider, which was initially approved in In the Matter of the Application of Duke Energy Ohio, Inc., for Approval of an Electric Security Plan, Case No. 08-920-EL-SSO, et al., Opinion and Order (December 17, 2008), at its expiration on December 31, 2011.
- (2) On November 18, 2011, a stipulation and recommendation (stipulation), signed by Duke, Staff, Ohio Consumers' Counsel, Ohio Partners for Affordable Energy, Ohio Environmental Council, People Working Cooperatively, Inc., Natural Resources Defense Council, Environmental Law and Policy Center, Vectren Retail, LLC d/b/a Vectren Source, and the Sierra Club, was filed. The Ohio Energy Group was not a signatory party to the stipulation.
- (3) The hearings in this matter were held on November 29, 2011, and June 7, 2012, and the parties filed briefs on December 9, 2011, and June 22, 2012.
- (4) On August 15, 2012, the Commission issued its opinion and order in this case, which, among other things, approved the stipulation, as modified therein.
- (5) The Commission notes that the last sentence in the first full paragraph on page 15 of our August 15, 2012, order should read: "[w]ith respect to a cap mechanism, based upon the evidence presented in this case, the Commission does not

believe it is necessary to limit Duke's potential energy efficiency performance, when customers receive no less than 87 percent of the benefit."

It is, therefore,

ORDERED, That the Commission's August 15, 2012, opinion and order be modified *nunc pro tunc* as set forth above. It is, further,

ORDERED, That a copy of this entry nunc pro tunc be served upon all parties of record.
