Dear Ms. Thomas-Dalton and Docketing Division:

Please allow this letter to serve as CSX Transportation's formal response and answer to those allegations contemplated by Rule 4901-9-01 of the Ohio Administrative Code (revision effective April 4, 1996). The complaint by the UTU was filed on August 10, 2012 and served on CSXT on August 20, 2012. The cover letter from PUCO directed an answer be filed within 15 days after August 14th.

In the complaint submitted by Stuart W. Gardner, on behalf of the UTU, it alleges excessive weeds and vegetation at the west end of the New Yard in the Columbus Terminal, Hamilton County, Ohio.

Upon receipt of the Complaint, an investigation into the allegations was undertaken. CSXT's Roadmaster, Michael Forlenzo, advised the area was sprayed for weeds on August 8th. A crew returned on August 10th to cut down any remaining vegetation. The tracks that were addressed were New Yard 12, 9 and Parsons 16, 17 and 18.

CSXT remains committed to promptly complying with the statutes of Ohio and the rules and regulations of the Commission to ensure the safety of railroad personnel and the public.
