WITHDRAWAL OF APPLICATION OF CAIMAN EASTERN MIDSTREAM, LLC FOR PERMANENT RELIEF FROM JURISDICTION

Now comes Caiman Eastern Midstream, LLC, (the "Applicant" or "Caiman"), through its attorneys, and withdraws its Application for Permanent Relief from Jurisdiction.

The recent passage of Ohio Senate Bill 315, which was signed into law by Governor Kasich on June 11, 2012, and which became effective on September 9, 2012, makes Caiman's filing moot. There is no longer the need to seek relief from jurisdiction, as the law now provides a statutory exemption for gas gathering operations such as Caiman's. See ORC § 4905.03(6), which defines a "public utility" as "[a] pipe-line company, when engaged in the business of transporting natural gas, oil, or coal or its derivatives through pipes or tubing, either wholly or partly within this state, but not when engaged in the business of the transport associated with gathering lines, raw natural gas liquids, or finished product natural gas liquids."
